CPO Course General Information & Registration

- The CPO Class requires a two day class (14-16 hours) taught by a certified instructor.
- Certification requires the completion of an open book written examination.
- The CPO Certification is valid for five years
- Classes are typically comprised of industry and aquatic care professionals.
- Course cost includes the Operator Handbook.
- Topics include a section for local and state codes. In South Carolina, the program includes the supplemental DHEC exam.
- CPO Certification is recognized nationally and is required in most areas.
