### 1. A rebate will be given to qualified registered dealers on all Imperial Pools, Inc. manufactured products purchased in 2017. (Some exclusions apply, see below.)

- 2<sup>%</sup> on components

### 2. How to Register

- Registration form must be submitted and signed by Dealer and Imperial Sales Director
- Registration received by 3/31/17 are eligible for purchases from 11/1/2016
- Registration received after 4/1/17 are eligible for purchases no more than 30 days prior to registration date
- Eligibility restrictions may apply

### 3. Qualifiers
