With Liner Guard, you will be able to offer labor and expense protection for up to 5 years and an enhanced liner product warranty up to 20 years prorated with the first 5 years covered in full.

We offer 4 Levels of available  coverage (*Diamond*, *Platinum*, *Gold* and *Silver*) that are purchased from us after filling out and signing **The Vinyl Works, Inc®. Extended Service Contract**.

- *Diamond Extended Service Contract* offers up to \$3000.00 of eligible reimbursement.
- *Platinum Extended Service Contract* offers up to \$2000.00 of eligible reimbursement.
- *Gold Extended Service Contract* offers up to \$1500.00 of eligible reimbursement.
- *Silver Extended Service Contract* offers up to \$1000.00 of eligible reimbursement.

1. The Extended Service Contract will apply to all in-ground liners purchased from the effective contract date. Contract will renew automatically each year unless either party notifies each other in writing. Contract price is subject to price increases as deemed necessary with 30 day minimum notification.
2. All expenses submitted for reimbursement must be accompanied by an Extended Service Contract Claim Form. This Form must be supported by proper receipts and/or invoices from applicable entities performing labor or providing material. Claim and receipts must not exceed the coverage amount.

The Extended Service Contract applies to:

- a) *In-ground liners found to be defective under the terms of The Vinyl Works 'Limited Warranty for Residential Swimming Pool Liners'*
- b) *In-ground liners with fabrication mistake or shop/clerical error only when original order is submitted in writing on a Vinyl Works Order Form. Verbal orders will not be accepted.*

Acceptable expenses eligible for reimbursement:

- *Labor to remove defective liner*
- *Labor to install new liner*
- *Materials needed to prepare pool bottom for new liner installation*
- *Water to fill pool*
- *Chemicals to balance new pool water*
- *Freight charges for new liner*

LINER FABRICATION ERROR REIMBURSEMENT (Limited)

Detectable and Concealed

1) Detectable Error

If a liner is made incorrectly due to a fabrication, shop or clerical error by The Vinyl Works and is detectable prior to installation, reimbursement is covered under "Liner Fabrication Detectable Error".

Example: Vinyl stair ordered in 'Left' position and box/packing slip indicates 'Right' position. STOP- DO NOT INSTALL.

» What You Can Expect

If considered a 'Detectable Error', a \$250.00 credit will be issued immediately. No claim form, freight bills or expense documentation are required and will not be accepted.

2) Concealed Error

If a liner is made incorrectly due to fabrication, shop or clerical error by The Vinyl Works and is only detectable while attempting to install liner, reimbursement is covered under same provisions as 'Liner Defect Reimbursement'.

Example: Liner ordered in 6' depth, box/packing slip indicates 6' depth but liner fabricated in 8' depth.

» What You Can Expect

If considered a 'Concealed Error', it will be treated as a 'Defect' and would be eligible for expense reimbursement.

Dealer Responsibilities:

- » Order must be submitted in writing using Vinyl Works Order Form.
- » Confirm liner received is consistent with order placed.
- » If information on box/packing slip is incorrect vs. order sent, STOP- DO NOT INSTALL.

Always check for accuracy: the liner pattern, mil; stair, cuddle cove, bench color or location; and dig dimensions or any applicable information. Inspection is your responsibility regardless of who receives the liner into your inventory. New or untrained personnel or subcontractor does not waive this responsibility.

Terms & Conditions:

1. *Extended Service Warranty is effective only on A) in-ground liners installed in a consumer's pool that is found to be defective under the terms of the Vinyl Works Warranty. A defect is defined as a seam de-lamination caused by an improper sealing of the seams. B) A mistake in fabrication; or a shop or clerical error recognized to be the fault of the Vinyl Works and original order was submitted in writing on Vinyl Works order form.*
2. *Claim must be submitted within 90 days of replacement installation, using LinerGuard claim form.*
3. *Contract price will be charged to each liner invoice as a separate line item as a NET figure. (Not discountable)*
4. *All liner specifications such as color/pattern, mil, dimensions, stair/bench location are the dealer's responsibility to confirm as ordered before installing the vinyl liner.*
5. *Acceptable expenses eligible for reimbursement exclude any repairs to pool walls, structure and coping.*
6. *The Vinyl Works retains the right to determine what is a fair and customary fee for work performed and materials provided in replacing defective liner.*
7. *All Vinyl Works liners are packaged with an Owners Manual and Warranty. Failure to comply with installation instruction, proper care or warranty terms voids this contract.*
8. *Dealer agrees to deliver Owners Manual supplied in liner box to retail consumer.*
9. *If a liner is replaced under the terms of this contract, a new "Extended Service Contract" is required for the new liner.*
10. *This contract is non-transferable and is enforceable only by the original contract dealer signee listed below.*
11. *The "Time of Purchase" is defined as the invoice date.*
12. *Reimbursement will be applied as a credit to dealer account.*

SPECIAL LINER REPLACEMENT PROCEDURES



In an effort to improve quality, process, and standards, The Vinyl Works® will be instituting a liner replacement protocol. Our primary goal is to improve both the quality of products and satisfaction of our mutually shared Retail Customers; at the same time preserving the reputation and relationship we share with our partners, the Pool Professionals. Installing and manufacturing multiple liners hurts all parties involved, both in time, treasure, and reputation, so getting the second liner correct is crucial.

When reporting a special liner fit issue, a second liner will not be manufactured until all manufacturing and installation issues are thoroughly investigated. Examining all possibilities for why the first liner did not fit will be standard procedure. Establishing the necessary changes needed to put the replacement liner into production is essential to authorizing remanufacturing. Outlined below is the systematic approach that will be used to investigate what changes need to be made so the replacement liner will fit and be scheduled for manufacturing.

1. Upon identification of issue, call or email The Vinyl Works® Corporate Services Department with the liner order number, job name, and liner serial lot number. Explain the problem with liner fit. ***Ideally this process will begin with a jobsite call happening in real time when liner fit issue is identified, which will result in the most expedited services.***
2. Provide The Vinyl Works® with pictures showing the liner installed in the pool with the vacuum turned on and detailing problem area or areas. (If the pool is filled with water, take pictures showing this.)
3. After reviewing all of the information that we have, ***a Manager or Department Head will call you directly and explain*** what The Vinyl Works® needs so we can figure out what is causing the fit issues with this liner.
4. It may require that the pool be remeasured using our On-Point/Pool Measure Pro App or doing an A/B measurement procedure using the paper-based method. If the issues are in a Stair, Sundeck, Bench or Cuddle Cove, completely new measurements will be needed. We must confirm that these products have been installed square, level, and with the correct finished dimensions as required for proper liner fit. We may send CAD drawings made for these products without any measurements on them, just blank spots indicating what we need measured. ***If deemed necessary, it may be required to report from the jobsite, so The Vinyl Works® can instruct the dealer on gathering the information needed for a proper fit. This will not be an option. (When required, pictures and/or videos can be sent via Text, FaceTime or Email.)***
5. Liner Warranties and/or Liner Guard Extended Protection Claim Reimbursements will be conditional on the participation and results of this new procedure.
